- vii. An Affidavit from the appointee to the effect that she has studied upto a maximum of 12<sup>th</sup> Class only.
- viii. All other relevant documents as are required under SRO-43 of 1994



## The appointment of the appointee shall further be subject to the following conditions:-

- a. That she shall give an undertaking in the shape of an Affidavit to the effect that if, on verification, any document produced by her is found fake/forged, the appointment shall be treated to have been cancelled ab-initio and legal action, as warranted under law, shall be initiated against her.
- b. The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of genuineness of all documents is received from the concerned issuing authorities in her favour.
- c. The appointee shall be initially on probation for a period of two years from the date of joining.
- d. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24-12-2009.
- e. If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, she shall forego her right to appointment, which shall be deemed to have been cancelled ab-initio, without any further notice. Con 11. 10.20 m
