Pursuant to the approval conveyed by the Home Department, J&K vide communication No. Home-Jail/70/2025-10-Home (7645473) dated 08.07.2025 and recommendations from J&K Service Selection Board, Jammu/Srinagar vide communication No. JKSSB-Secy/2/2025-06 (E-7628025) dated 30.04.2025, sanction was accorded to the appointment of **Mr. Vasu Dev Singh S/o Jagjeet Singh R/o Gurha Slathain, Vijaypur Samba as Junior Assistant under "EWS Category" in the Pay Level-4 (25500-81100)** against available vacancy in the Prisons Department vide Prison Headquarters, J&K **Order No. 361-Prison of 2025 dated 10.07.2025.**

The matter has been examined / considered with reference to the rules governing the subject. The concerned official is still on probation and has not qualified prescribed probation period of service. Rule 21(1) of J&K Civil Services (Classification, Control & Appeal) Rules, 1956 provides as under :-

"At any time before the expiry of prescribed period of probation the appointing authority may" :

- a. Suspend the probation of a probationer and discharge him from the service for want of vacancy; and*
- b. At its discretion terminate the probation of a probationer and discharge him from the services.*
