An amount of ₹ 2000/- (rupees Two thousand only) towards cost of tender fee has to be deposited in Government Treasury by the bidder under **Major Head - 0056 in favour of Accounts Officer, District Jail Kathua.**

Scanned copy of the Treasury Challan towards deposit of amount of tender fee has to be necessarily uploaded along with the bid documents.

The bidder has to submit Earnest Money of ₹ 4.00 lakhs (Rupees Four lakhs only) in the form of **CDR/FDR** issued by a scheduled bank, drawn and pledged in favour of **Superintendent, District Jail Kathua**. The bidder has to upload the scanned copy of the CDR/FDR alongwith other documents during submission of bid within the above-mentioned date and time of bid submission. **The bidder who have already uploaded the CDR worth Rs.4.00 Lakh in lieu of e-NIT 01 of 2025 dated:-28.04.2025 need not to obtain fresh CDR and may upload the earlier CDR.**
