
**3. Tender Fee (Cost of tender documents) :**

An amount of ₹ 1500/- towards cost of tender fee has to be deposited by the bidder in the shape of Treasury Receipt in the Major Head : 0056 (Jails).

Scanned copy of the receipt towards deposit of amount of tender fee has to be necessarily uploaded along with the bid documents.

The bidder has to submit Earnest Money of ₹4,00,000/- (Rupees Four Lakh only) in the form of CDR/FDR issued by a scheduled bank, drawn and pledged in favour of Superintendent Sub Jail Hiranagar (now Holding Centre Hiranagar) and payable at Hiranagar. The bidder has to upload the scanned copy of the CDR/FDR alongwith other documents during submission of bid within the above-mentioned date and time of bid submission.
