3. Tender Fee (Cost of Tender Documents)

An amount of Rs. 1000/- towards the cost of tender fee has to be deposited by the bidder in the shape of Treasury Receipt in the Major Head : 2056-Jails :
Scanned copy of the receipt towards deposit of amount of tender fee has to be necessarily uploaded along with the bid documents.

4. The date and time of opening of bids shall also be notified on website www.jktenders.gov.in.
5. The bidders have to submit their bids online in electronic format with digital signature. No bid shall be accepted in physical form.
6. Bidders also ensure to upload scanned copy of all necessary documents with the bid.
7. Bidders must ensure to upload scanned copies of all necessary documents including earnest money deposit and tender document fee with technical bid and the successful bidder has to submit the hard copies of all the uploaded documents duly attested at the time of allotment of contract. No documents which has/have not been uploaded at the time of submission of bid shall not be entertained in the form of hard copy later on. However, in case of any clarification, the bidders shall have to produce original documents in support of soft copies if need arises.
8. The successful bidder will be required to deposit CDR/FDR towards EMD in original in the office of Superintendent, Sub Jail Hiranagar within 07 days of opening of financial bid.


9. The earnest money in favour of unsuccessful/non-responsive bidders shall be released only after ensuring submission of tender documents fee in original, irrespective of hard copies, failure of submission of tender documents fee by bidder using the site shall entitle him for blacklisting.
10. The department will not be responsible for delay in online submission due to any reason.
